When I was twelve years old, I earned my copy of *Little Women* by writing poetry and stories for the Worcester Telegram and Gazette's "Happy Time Page." It is tattered and worn and very well loved. *Little Women* was my Mom's favorite story and her absolute favorite movie (the Elizabeth Taylor version, of course). Each time I read it, I feel like I am going home again.

The incomparable Louisa May Alcott wrote characters that we still relate to 150 years after *Little Women* was first published. I always wanted to be Jo, of course. Independent and smart and talented, Jo taught me that girls could be and do anything. Some days, I'm definitely more of an Amy. In reality, I'm a mixture of all the sisters as most of us are.

Little Women: The Broadway Musical takes Alcott's story and heightens it as all good musicals do. Through song and movement we get to know the characters' needs and desires more deeply. I hope you'll enjoy hearing this story sing as much as I do.

Today you'll see some very familiar faces to GBSC as well as some astonishing newcomers. I could not have asked for a better, kinder, more amazing cast to work with. The creative team has gone above and beyond for this production, but I must particularly thank the set designer and my friend, Shelley Barish. The pop-up style storybook of a set that Shelley created has been the most wonderful playground for us. I would be remiss if I did not thank the two silent and one not-so-silent heroes of every musical. First, the not-so-silent incredible music director Matt Stern. Next, Shauwna Dias Grillo, Production Stage Manager extraordinaire (and her team of Fitz, Cassie, and Art). Lastly, my very own Lord of the Dance, Dance Captain Kevin Patrick Martin. Kevin was in the very first production I directed professionally here. For the past few years, he has been on the National Tour of *Jersey Boys*. I am lucky to have had him come back to GBSC as his first return to regional theater when the tour closed. I'm even luckier to call him my friend.

I hope that your experience today, coming to Greater Boston Stage Company to watch this beautiful story unfold with old friends and new, is the type of return I get every time I revisit *Little Women*.
